The City of Bunnell has two vacancies on the PZA Board and is seeking volunteers to fill these positions. These volunteers must be residents of, or own property in, the City of Bunnell. The City prefers the volunteer be a member of one of the following professions: an architect, business person, engineer, general contractor, landscape architect, property appraiser, land use planner, subcontractor, realtor or attorney; however, any City resident or property owner is encouraged to apply. The duties of the PZA Board include serving as the local planning agency, reviewing changes in the Land Development Code, making recommendations to the City Commission, and hearing administrative appeals. The PZA Board meets at 7:00 p.m. the third Tuesday of the month and members serve 3-year terms.
