Public Notice of Aerial Spraying

In compliance with regulations of the Federal Aviation Administration (FAA), public notice is hereby given that East Flagler Mosquito Control District may apply control products by helicopter over or adjacent to congested areas of Flagler County and Bunnell. The purpose of these flights is for the suppression of mosquito populations. Flights will normally be performed at an altitude of 500 feet. Additionally, the District may perform low level flights over and adjacent to wetlands for the purpose of arresting mosquito development.

All flights will be in the public interest, and at times, maximize public safety and mosquito control effectiveness. All control products are approved for control purposes by the Florida Department of Agriculture and U.S. Environment Protection.

Proclamation approved designating April as Water Conservation Month

The St. Johns River Water Management District's Governing Board approved a proclamation on March 10, 2015, designating April as Water Conservation Month to heighten awareness about the importance of water

conservation.

April has been formally recognized as Water Conservation Month in Florida for the past 17 years, as April is typically a dry month when water demands are higher due to springtime planting.

"Water conservation is at the core of the District's mission of protecting and ensuring the sustainability of Florida's water supplies," said John Miklos, chairman of the District's Governing Board. "Recognizing Water Conservation Month helps to encourage water users to take simple steps to conserve."

More than half of all residential water use is outdoors for lawn and landscape irrigation. Following districtwide lawn watering rules helps ensure the efficient use of water for landscape irrigation. The rules specify the days when residents and businesses may water. These days depend on whether the property has an odd or even numbered address.

The rules allow irrigation up to two days a week, before 10 a.m. or after 4 p.m., from March to November, and up to one day a week during the cooler months of Eastern Standard Time.

Watering wisely year-round promotes healthier lawns and landscapes and can save thousands of gallons of water per month, as well as save homeowners money. Overwatering a lawn can promote weeds and insect pests, as well as weakened grass roots.

Water Treatment Plant Progress

Since last month's progress report of the new Ion Exchange Water Treatment Plant showing the assembly of the steel structure and support system, a lot more construction has taken place with more steel systems going into place and the start of the siding and insulation. Multimedia filters with the stairs and the catwalk are now going in as well.



Steps forward now include the installation of the roofing system showing the development of the new facility steadily approaching completion. Once the roof is on and side structure is done then the water treatment assembly will begin and the offices will follow.
