Each business with a valid BTR should have received a renewal notice either by e-mail or a postcard from the Flagler County Tax Collectors Office in July. You can renew on-line at www.flaglertax.com or go to the Tax Collector offices to pay in person. You will renew your Bunnell and Flagler County BTRs at the same time. 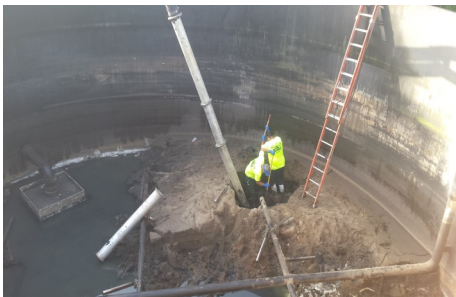

Wastewater Treatment Plant:



The Utilities Department recently spent a great deal of time and hard work cleaning the City of Bunnell's FE Tank at the Wastewater Treatment Facility. The work was performed by the City's maintenance workers, the Wastewater Treatment Plant operators and several additional staff members during the month of July.

The cleaning of the Flow Equalization Tank took several weeks of long, hot, grueling work and we wish to thank all of those involved for their outstanding work and dedication to our City.

Now that the WWTP FE Tank is cleaned, inspection of the air header presented some repair needs which will expectantly

begin next week and will include replacing old pipe with a much more durable stainless steel piping. Stainless Steel is a highly resistant material to corrosion and will prove more durable and cost effective for the future.

Again, we wish to thank all those involved in this challenging project which illustrated a big success to our staff and the City of Bunnell.

From the Desk of the Fire Chief :

DURING AN EMERGENCY

Hurricanes and Tropical Storms:

- Stay informed by monitoring the latest forecasts and warning from the National Weather Service, as well as information and advice from local emergency management officials. Local news and radio broadcasts will detail Flagler-specific information.
- Bring in anything that can be picked up by the wind (bicycles, lawn furniture).
- Close your windows, doors and hurricane shutters. If you do not have hurricane shutters, close and board up all windows and doors with plywood.
- Turn your refrigerator and freezer to the coldest setting. Keep them closed as much as possible so food will last longer is the power goes out.
- Unplug small appliances.

- Fill your vehicle's gas tank.
- Implement your family's disaster plan and stay calm.
- Evacuate if ordered to do so. Bridges will be closed to all traffic, including emergency responders, once tropical storm force winds arrive.

Should I Stay or Should I Go?

If you live beachside, be prepared to leave. The area east of the Intracoastal Waterway is considered a primary hurricane evacuation zone.

If you live in an evacuation zone, be prepared to leave if an evacuation is ordered for your zone.

If you live in a mobile home, manufactured home or recreational vehicle, also be prepared to leave. Mobile homes, manufactured homes and recreational vehicles must be evacuated countywide for any hurricane. Even if you live inland and have tie-downs, these buildings may not withstand hurricane conditions or wind-borne debris.

If you live west of I-95, outside evacuation zone in a newer, well-constructed home, consider sheltering home, unless ordered to evacuate by emergency management
