Business Tax Receipts

All Business Tax Receipts (BTRs) expire September 30, 2016. BTR renewal season begins in July. In accordance with an Interlocal Agreement, the City of Bunnell currently partners with the Flagler County Tax Collector's Office for all Local Business Tax Receipt Renewals. Each business with a valid BTR as of June 1, 2016 will receive a renewal notice either by e-mail or postcard from the Flagler County Tax Collector's Office starting mid to late July 2016. You can renew your BTR in one of the following ways:

1. Online at www.flaglertax.com
2. Mail in the entire payment for both the Flagler County and City of Bunnell business tax receipt to the Flagler County Tax Collector's Office at PO Box 846 Bunnell, FL 32110
3. Go to the Tax Collector's office to pay in person.

When searching for your business on the Tax Collector's website, please be advised that some businesses have more than one account. Please make sure that you search for all accounts associated with your business and pay them all at one time. Penalties start to accrue on October 1st.

Special Needs Shelters:

Flagler County Emergency Services dedicates a shelter for people with special needs during an evacuation. A Special Needs Shelter is available for individuals whose capabili-

ties require assistance in the management of their illness, ailment or injury. A family member or caregiver should stay at the shelter with the individual. The shelter is not available for individuals who are in a care facility (such as a hospital, nursing home or congregate living facility) or are bedbound.

The Special Needs Shelter is a temporary facility capable of providing limited medical care to individuals who require services of a caregiver or home health care provider in their everyday activities due to medical conditions and/or disabilities. The Special Needs Shelter or any evacuation shelter will only be available as a last resort for people who have no other place to go. These shelters cannot offer the same level of care this is available in a hospital or other healthcare facility. If you need to evacuate, seek shelter with relatives, friends or in hotels/motels when possible/feasible.

Supplies at the shelter are limited, and it may be several hours before more supplies arrive. You should bring at least a 72-hour supply of all medications (in original containers, medical supplies (i.e. gauze, saline, etc.) and personal items (i.e. hygiene products, clothing, diapers, pillows, blankets, etc.) in a small travel bag to the shelter. A maximum of one suitcase is allowed due to space limitations. Furthermore, air mattresses are not permitted. If you place to bring your service animal, you would also need to bring supplies relevant to it's needs (food, travel bowls, safety harnesses/leashes, cages/carriers, sanitary supplies, any needed medication, bedding and identification.

The Special Needs Shelter is coor-

inated by the Emergency Management Division and involves the Flagler County Health Department, Flagler County Senior Services and the Flagler County School Board. The Flagler County Health Department will review each application to verify qualification. Home health agencies are responsible for registering their clients with the Flagler County Emergency Management special needs database. Individuals may also register themselves or a family member.

Pre-registration is important for persons with special needs. During an emergency is not the time to get on the People with Special Needs list. Attempting to register during an emergency causes a critical delay, and inhibits the ability of Emergency Management to render services to our vulnerable population.
