

Roundabout Design Project PUBLIC HEARING



The Florida Department of Transportation (FDOT) is designing a roundabout at the intersection of State Road (S.R.) 5/U.S. 1 at Old Dixie Highway in Flagler County (circled in red on the project location map to the right).

This project will include operational and safety enhancements to improve the flow of traffic. The roundabout design will include four approaches; a south approach on U.S. 1, north approaches on U.S. 1 and County Road (C.R.) 325, and an east approach on Old Dixie Highway. No additional right of way will be required.

A Public Hearing will be held to introduce the project and present the design concept to the public.
